13 **An Ordinance of the Pierce County Council Amending Section 2.61.030 of**
14 **the Pierce County Code, "Composition," Revising the**
15 **Composition of the Anderson Island Citizens' Advisory**
16 **Board.**

18 **Whereas**, the Anderson Island Citizens' Advisory Board (AICAB) was
19 established in 2004 to facilitate communication between the County and Island
20 residents, property owners, and business owners regarding significant issues affecting
21 the community including land use, environmental regulations, infrastructure, schools,
22 ferry service and public safety; and

23
24 **Whereas**, the AICAB meets quarterly to discuss a variety of issues related to
25 Pierce County government that concern Anderson Island residents, including land use
26 regulations, public safety, and ferry service to the Island, and regularly communicates
27 their findings to the appropriate Pierce County officials; and

29 **Whereas**, the AICAB consists of 11 members representing a variety of Anderson
30 Island organizations; and

31
32 **Whereas**, representatives on the AICAB are appointed by the County Executive
33 and confirmed by a majority of the County Council through Resolution and may serve
34 two consecutive 4-year terms; and

36 **Whereas**, at its January 12, 2023, meeting, by unanimous vote, the AICAB
37 recommended that the Anderson Island Community Club representative be replaced
38 with a representative from Island Arts; **Now Therefore**,

ANDERSON ISLAND CITIZENS' ADVISORY BOARD

2.61.030 Composition.

The AICAB shall consist of 11 voting members, one representative from each of the following Anderson Island organizations: American Legion Post 265, Anderson Island Association, Anderson Island Crime Task Force, Anderson Island Historical Society, Anderson Island Community Club, Island Arts, Anderson Island Elementary School Booster Club (Parent Teacher School Association), Anderson Island Park and Recreation District, Anderson Island Fire and Rescue District, Anderson Island Quality of Life Committee, Riviera Community Club, and Tanner Electric Cooperative. These representatives shall be appointed by the County Executive and confirmed by Resolution by a majority of the County Council.
